A meeting of the Procurement Committee (PC) constituted under Rule (7) of SPP Rules 2010 (Amended 2013) for the above work was held to evaluate the financial bids opened publicly in presence of the bidder's representatives and the PC members as per schedule on August 11, 2015 at 2:00pm. The procedure for bidding was adopted as Single Stage – One Envelope Procedure.

The detail of Prices at opening of the Financial Proposals is given in the following table;

The PC read through each proposal in detail and checked for compliance with Bid Documents. After detailed evaluation, it was observed that the Proposal of M/s Techsys & Co. was complete and he has priced all items and provided required documents in accordance with Bid Documents. M/s Tekno Star Co. has not agreed with the completion period of 30 days and proposed to supply the


equipment in 3 months. He has only provided the Financial Statement of 1 year. Similarly, M/s Rayyanco Business System has not complied with all requirements as he did not quote the rates of all items and also not provided the Financial statement of last 2 years and affidavit for blacklisting.

While checking arithmetical errors, no computational errors were noticed in the Financial Proposals and hence no adjustments are required.


M/s Tekno Star and M/s Rayyanco has deviated from the basic requirements thus the PC disqualified their proposals, whereas the proposal submitted by M/s Techsys & Co. has been qualified.

The PC recommends to approve the financial proposal of M/s Techsys & Co. being the lowest evaluated bid at the offered Price of Rs.888,750/-.


